School Uniform Policy

It is our school policy that all pupils wear school uniform when attending school, representing the school, or when participating in a school-organised event outside normal school hours.

Aims and Objectives

Our policy on school uniform is based on the notion that school uniform:

- promotes a sense of pride in the school
- engenders a sense of community and belonging towards the school
- is practical and smart
- identifies the pupil with the school
- prevents pupils from coming to school in fashion clothes that could be distracting in class
- makes children feel equal to their peers in terms of appearance
- is regarded as suitable wear for school and good value for money by parents / carers
- is designed with health and safety in mind

April – July 2025 (interim policy following the close of Elizabeth's Embroidery)

Our school uniform consists of:

- **White Shirt and Longfield clip on tie* with Longfield Jumper * OR Longfield Polo Shirt* and Jumper ***
- **Longfield V-necked Jumper * (compulsory) wearing of this is compulsory in winter and optional in the summer**
- **Longfield Blazer * (optional)**

As of 1st September 2025

Our school uniform consists of:

- **White Shirt (short and long sleeved)**
- **Longfield clip on tie***
- **Longfield V-necked Jumper * wearing of this is compulsory as it is the only embroidered item of school uniform. However, pupils will be permitted to remove this in warm weather**

* Indicates branded / school specific items of uniform that can only be purchased via our uniform supplier. The only visible logos should be that of Longfield Academy.

A branded polo shirt will be available to those with a sensory need diagnosed. This must be agreed by the school before purchase.

We no longer have a different winter / summer uniform. Polo shirts cannot be worn except by those who have specific approval by the school.

In addition to the above branded school uniform items, pupils should also wear:

Plain black trousers - standard fit and not made from leather, corduroy or denim. Leggings, jeggings, black jeans and ¾ trousers are not permitted. ***Trousers must have a button and zip fastening (not decorative).***

Any alternative to this expectation must be discussed and agreed with the academy.

All pupils should be in trousers as skirts are not part of our school uniform.

Black shoes - shoes should give adequate cover of the foot for health and safety reasons. Trainers and plimsolls shoes are not acceptable. Shoes should be polishable and made of a substance that protects the foot from water.

Shoes must be plain black and not have visible stripes. We discourage badges or logos of any kind. If footwear is not deemed suitable by the academy, we will loan an alternative where possible. All pupils will be expected to wear the alternative offered.

Black Boots – as per appendix examples only. Boots should be flat, polishable and made of a substance that protects the foot from water.

Many teenage and young person fashion shops sell trousers and shoes / boots, which contravene these rules in their 'school' section; these are unacceptable. Please see appendix 1 at the end of this policy for example images.

Coats - should be an appropriate outdoor coat - no sweatshirts, hooded tops, cardigans, tracksuit tops or coats made of denim. We have systems in place to confiscate and look after any items that do not follow our policy. We will not be held responsible for any item that is lost due to confiscation.

Jewellery – no earrings, or other jewellery. Watches are permitted, except for exams. This excludes Smart Watches, which are not allowed at any time. A pupil may be asked to remove any item of jewellery. We have systems in place to confiscate and look after any items that do not follow our policy. However, we will not be held responsible for any item that is lost due to confiscation and ask that jewellery is left safely at home.

Any piercings should be done during the 6-weeks holiday. Newly pierced ears/nose/tongue etc. will not be an acceptable reason for failing to remove a jewellery item. Retainers are not also permitted.

Nails - For health and safety reasons, false or coloured nails are not permitted. Removal will be expected as soon as possible. Nails should always be of practical length as determined by the Academy.

Makeup - If make up is desired, it must be natural. Excessive make-up is not acceptable. Fake eyelashes / lash extensions are not permitted.

Extreme hair dyes / multi coloured hair is not acceptable for any pupil – hair must be a natural colour. Hairstyles / eyebrows must not have any lines, patterns or symbols showing. Examples of unacceptable hairstyles are dip dying, razor fading or high siding. A number zero/one hair cut is not permitted on any part of the head.

A **school bag** large enough to carry an A4 file must be carried every day.

Pupils must attend school with the **necessary school equipment** each and every school day: Pen, pencil, rubber, calculator, practical equipment (where necessary) e.g. PE kit, ingredients etc.

A set of basic equipment is provided by Longfield Academy at the beginning of the year. Replacements can be purchased via the equipment shop at a small cost.

If an item of uniform is not deemed suitable by the academy, we will loan an alternative where possible. All pupils will be expected to wear the alternative offered.

We will not be held responsible for any item that is lost due to confiscation and therefore, we ask that all items are left safely at home.

PE Kit

- Longfield Logo - PE Polo Shirt*
- Longfield Logo – Long Sleeved PE Top/Jacket*
- Plain Black Shorts / Skort or alternatively, Leggings / Tracksuit Bottoms
- Plain Black Football Socks
- Black Swim Shorts / Costume
- Swimming Goggles
- Swim Hat (for long hair)
- Shin Pads (compulsory)
- Mouth Guard (compulsory)
- Training Shoes (non-marking, for indoor activities)
- Football Boots / Trainers (for outdoor activities)

*** Indicates branded / school specific items of uniform that can only be purchased via our uniform supplier. The only visible logos should be that of Longfield Academy.**

Please note:

- (i) We have high expectations that all pupils are of a smart and respectable appearance, dressed in the correct uniform
- (ii) Pupils who do not follow the school policy for uniform will be issued with sanctions in line with the school's Choices (Behaviour) Policy

The Role of Parents / Carers

We ask all parents / carers who send their child to our school to support the school uniform policy. Parents / carers have a duty to send their child to school correctly dressed. One of the responsibilities of parents / carers is to ensure that their child has the correct uniform, and that it is clean and in good repair.

Diversity and Inclusion

The school welcomes pupils from all backgrounds, genders and faith communities. If there are serious reasons, for example on religious grounds, why parents / carers require their child to wear clothes that differ from the school uniform policy, the school will look sympathetically at such requests.

The school will consider special dispensation for pupils on an individual basis. Any changes must be with the agreement of the academy.

At Longfield, we are committed to providing value for money for parents / carers and our designated uniform will ensure the expense of uniform is limited. Should parents / carers wish to apply for funding support towards the cost of uniform, please contact the school.

The Role of Governors

The governing body implements the school uniform policy. It considers all representations from parents / carers regarding the uniform policy and liaises with the Headteacher to ensure that the policy is implemented fairly and with sensitivity. It is the governors' responsibility to ensure that the school uniform meets all regulations concerning equal opportunities. Governors ensure that the school uniform policy helps pupils to dress sensibly, in clothing that is hardwearing, safe and practical.

Monitoring and Review

The governing body will monitor and review the school uniform policy through its committee work by:

- seeking the views of parents / carers to ensure that they agree with and support the policy
- requiring the Headteacher to report to the governors on the way the school uniform policy is implemented.

Appendix 1

Examples of Acceptable / Unacceptable Uniform Standards

We believe that dress and presentation help to create good personal standards among pupils; and parents / carers are requested to give their full support to the school in adhering to the uniform policy. In order to be fair and to promote consistency of uniform, we will sanction pupils who come to school with incorrect uniform or inappropriate haircuts / colours.

To support the uniform policy, we've provided some examples of acceptable / unacceptable uniform to assist our parents / carers.

Shoes / Boots

Acceptable Plain black shoes / Boots



No metal buckles / decoration. No heels. No trainers.



Trousers

Slim / straight fit with a zip and button fastening.



No jeans / No decorative zips / No jeggings / leggings



Financial Assistance

If your household income is less than £17,500 per annum or if your child is entitled to free school meals, you are eligible for financial assistance on uniform purchases. This entitles you to 50% discount on purchases, up to a maximum of £50 per year, per child.

Second-Hand Uniform
